Response to a request for official information

Thank you for your request for official information received 22 March 2022 by Nelson Marlborough Health (NMH)¹, followed by the necessary extension of time 14 April 2022, where you seek the following information.

- 1. "Please indicate what is your exact procedure for determining that hospital admissions in this current time are in fact directly due to covid:
 - (a) Ie: are u testing people who are admitting themselves for something non respiratory related and if they test positive after admission for sars cov 2 are you listing it as a covid admission regardless"

NMH response:

Hospital admissions are tested for COVID-19 by a rapid antigen test (RAT) which detects protein from the virus, or a PCR, which identifies genetic material from the virus.

The primary reason for a patient's admission will be recorded alongside their COVID-19 status.

Patient admissions directly due to COVID-19 are admitted with COVID-19 as the *Primary* cause for hospitalisation. If the primary reason for admission is non-respiratory, and the patient tests positive for COVID-19 straightaway or during the admission, patients are admitted with COVID-19 as *Incidental* to the primary reason for hospitalisation.

(b) "ie: people who are admitted for something respiratory related that is later diagnosed as not sars cov 2, are you indicating them as covid hospitalizations if they return a positive test during admission."

NMH response:

If the primary reason for admission is a respiratory illness, and the patient tests negative for COVID-19, repeat testing is necessary to make sure the early tests are not false negatives. A patient developing a positive test for COVID-19 many days into their hospital stay may have had a long 'incubation' period i.e had COVID-19 since admission, or contracted COVID-19 while in hospital. In the latter case, testing would have revealed the initial cause of their respiratory illness (bacterial or viral).

We note that daily COVID-19 data available in the public domain under the term 'hospitalisations' refers to the number of patients in hospital that day with a confirmed diagnosis of COVID-19, regardless of whether the hospitalisation is *Primary* ("from") COVID-19 or *Incidental* ("with") COVID-19.
